1. To vote you must darken the oval (●) completely next to the candidate or issue of your choice.

STRAIGHT TICKET VOTERS: "IF YOU MARKED A STRAIGHT TICKET" When you mark any individual candidate in a different party, that vote will override your straight party vote for that office. When you mark any individual candidate in a different party for an office where more than one will be elected, **YOU MUST MARK EACH OF YOUR CHOICES FOR THAT OFFICE** because your straight ticket vote will not be counted for that office.
